ALTERING HUMAN SOCIETY

What is happening to human society in the United States is a slick method of brainwashing formulated to alter natural and proper thought and action inclinations. The following is a summary of conclusions taken from a lecture by Professor Dean Gotcher who opposes these changes being made to American society. I have prepared this resume' for one of my own radio talks, and added a minuscule amount of comments of my own. Some people are able to sense that the changes that are occurring are not proper, while some people are simply "go-a-long-ers" that do not easily detect what is actually happening to them. The following is what is going on totally within American society, government, and in the family, which is not by accident. It is planned to condition Americans for global government control! In summary, here's how the brainwashing works:

Known truths, standards, methods of conduct, and behavior are being altered for global government control. The process of teaching <u>known</u> truths and replacing <u>known</u> truths with <u>disputes and argumentations</u> is known as moving from being in a didactic state and going into a dialectic state.

It is worth restating: Didactic equals \underline{known} truth. Dialectic equals disputes and argumentation. We are being converted from \underline{known} truths (didactic) into the dialectic state, which is disputable, not stable, and the reverse of reality. It is being done for total management.

What happens is that a "new model" or a "new direction" is substituted for what was formerly thought to be the correct direction in a particular field. This is not only happening in the field of education, it is being done in the operation of the general government. It is also used on citizen 'advisory committees' as they are being brought to a "consensus". Informed persons recognize this by the term of Delphi -- the Delphi Technique. The intent of Delphi is to direct the people's thinking so that they come out to a pre-determined conclusion. While they think they are making their own decision, they are being manipulated into coming to a pre-planned conclusion or decision. This management technique has been known by many terms, Management By Objectives (MBO), Management Information System, Instructional Management, Uniform Accounting Systems, Planning, Programming and Budgeting System (PPBS), and many other terms.

In the military, dialectics is called "Total Quality Leadership". In the medical field, it is found in the H.M.O. With the police, dialectics is called "Total Quality Management". In the schools it is known as "Outcome Based Education". This mind-altering system is being used on the population in general, in the home, and with the families.

The dialectic process can be described as the merging of opposites. It ends up in a compromise by using what is called a 'consensus'. In a given discussion, the 'consensus' stops objectors and weakens wiser decisions and directions.

The person who promotes these actions is called the <u>facilitator</u> -- the facilitator is usually a psychologist or a sociologist. They are found in all fields of American society.

The new mode of operation is what the 'facilitators' call a paradigm. A paradigm means that a new - a different - example is set in place of a former mode or method of conduct or viewpoint or whatever.

The objective of the facilitator is: to break down barriers and normal restrictions and to set up against them. The facilitator (some times called the change agent) uses the "consensus" process, which stifles sensible protests. This actually results in "induced paralysis" of the objectors. Objectors to the process of "consensus" are made to feel like they are 'rocking the boat'. Those who object to the changes are encouraged to alter their standards so that "they can get along with others". The reason given to get rid of normal standards often is the claim that others are being 'offended'.

The plan is to remake human society and run the country according to the daydreams of socialist psychologists and their leaders. They are determined to remake human nature. In this process, theories are supplanted for realities.

Technically, what they are doing in this liberating process is liberating the people from the laws of God, and away from the factual world. This is all done at the cost of truth and the cost of reality. They prey on human passions instead of common sense. They work with "feelings" -- even though "feelings" are known to deceive people. It is causing discord amongst the ranks of teachers, police officers, yet the push goes on to alter the society.

Parents are made to abandon facts to please their children. Parents can not stand upon time-tested principles. Ultimately, the remaking of human society is expected to be achieved. The people, if they do succumb, then must think differently than the time-tested manner in which good families once directed their progeny.

The goals and objectives of this dialectic technique is to:

Get rid of national sovereignty,

- " " feelings of nationalism,
- " " property rights,
- " " rights of parents who wish to raise their children according to their own standards, and to
- " " tried and true principles of human conduct.

The facilitator teaches on how to circumvent the limits of the law. Since the objective is to prepare for global government management, the victims are actually caused to participate in the overthrow of their own lawful government in exchange for implementation of soviet councils of government.

The facilitators operate under the Hegelian techniques:

Thesis -- the Anti-thesis -- and the Synthesis.

As it is conceived, accountability is no longer to a higher and divine power. It is no longer taken into account that people <u>really are</u> accountable to a higher power. Accountability is only to one's own self. You are then only accountable to mankind (an atheist world).

There are no absolutes. It is left up to what you know, what you think and what you feel.

Society becomes confused, disappointed and may for a time, end up not knowing what to believe or how to act, until the soviets take full charge (cognitive dissonance).

Dialectic is not good for people who believe that we are obligated to a higher power, and that we are born with natural rights. It is not good for those who believe in limited government. That means limiting the power that man can exert over his fellow man, retaining sovereignty, liberty and independence.

The nation is being placed under Karl Marx's views. In the eyes of dialectic philosophers, nothing is established for all time. Nothing is absolute, and nothing is sacred.

Benjamin Bloom's "taxonomy" teaches the point of view that truth and knowledge are only relative. Outcome Based Education is based upon these theories. The proponents of these views believe that equality of opportunity becomes ever greater with the weakening of family power. In other words, in their view, it is necessary to create an experimental breach between parents and child. This view is undermining parental authority. Western civilization is being eliminated.

In the school, the child is tracked by a psychological portfolio. The name for the national test for teachers is known as praxis. It follows Antonio Gramsci's teaching of humanism. The mind and conduct are manipulated toward a pre-determined outcome. When the society is finally prepared, the system of soviets councils and soviet management can become fully operating.

This is what is happening in the United States under the direction of the federal government and those who are running the state governments and their subdivisions.

A foreigner recently made the following exclamation to one of my friends: "The American people are so dumb. They are so dumb, that they don't even know what is happening to them!"

Fortunately, we are being blessed with an article written by Detective Phillip Worts of the San Diego Police Department who recognized what was happening to the law enforcement division under which he is employed. He wrote a masterpiece to depict how dialectics was operating in the law enforcement system.

His article is easily understood and is composed of 9 pages. When first I saw it, I realized its potential. The police have the opportunity to expose what is happening all over this country.

Worts' article has the capability not only to awaken the American people as to what is going on, but we may be able to bring the police to our side when the house-to-house searches begin for prohibiting all guns.

As you know, the Holt bill (H.R. 124) called the "Handgun Licensing and Registration Act of 2003" requires every person in the United States to register any handgun they own. They must also be licensed after taking a safety course. If within two years from the passage of the bill, any one who gets caught not registering his gun(s), will be sentenced to a mandatory 15-year prison sentence. Being a federal law, the state courts will not be allowed to pre-empt this sentence. All unregistered handguns will be made useless by the Holt bill, because once a handgun is used in self-defense (even to save one's life from criminal attack), the user will be sentenced to prison for 15 years for not having registered it.

To me, H.R. 124 is a mop-up bill to catch everyone who has not been caught up in one way or another by other restrictive legislation. This comprehensive registering of all handguns indicates to me that government's plan for house-to-house searches is coming on soon.

To register your gun is to prohibit it. This is the goal of the law that was passed and signed by globalist John F. Kennedy. It is known as "The United States Program for General and Complete Disarmament in a Peaceful World." This law has never been rescinded and is enhanced each two years with appropriations to keep it funded by all subsequent Congresses. This law is also known by the title Public Law 87-297, and is called the parent document. In 1989 George H. Bush signed into law an enhancement to it, which is engrossed under the title of Public Law 101-216. It is an amendment, and repeats parts of P.L. 87-297. It also states that the nation must become completely disarmed, including transferring its national armed forces (on a permanent basis) to the Security Council of the United Nations to be used by communist commanders.
