

HB 1716 is pending legislation in Missouri of national importance. Originally it dealt with the normal rules relating to obtaining a driver's license. Fortunately, Missouri Repr. Jim Guest (a good and loyal constitutional state legislator) attached a provision onto this bill to prohibit Missouri from adopting the federal government's dishonest and treacherous "Real ID Card". Please help our sister state to get HB 1716 passed as it contains Repr. Guest's attachment (called the "Anti-Real ID Bill"). Passage of this bill will stop the ID Card from acceptance in Missouri.

Please make a phone call to persuade Reprs. Gibbons and Shields (two legislators who favor passage of the deceptive "Real ID Card") plus the Governor (a supporter of the North American Union!) that there is great national opposition to acceptance of the Real ID Card and the damage it will do to the privacy and authority of all citizens. Passage of HB 1716 in Missouri helps all states in their national effort to stop the federal deceitful "Real ID Card".

Action needed to pass Anti-Real ID bill (HB 1716): Word from Jeff City

Last night, Governor Blunt met with some of the Missouri Senators (Shields and Gibbons) and he is pressuring them to not allow the Anti-Real ID bill to pass. Blunt does not want to have the veto it as this will expose the fact that he is part of the anti-America agenda being implemented by the Feds. (If you're not aware, Blunt and Federal Mo Legislators made a trip to China recently to work on North America Union (NAU)/inland port/corridor issues).
