Dear Friend:

Enclosed please find our latest sheet which was drafted to assist voters in the selection of a governor for the State of California. The deception on the part of the anti-gun forces in California (which this sheet exposes) applies to a similar situation in every state. The commission that the federal government created (the Law Enforcement Assistance Administration) worked over every state in the nation, with a similar version of the "California Page 340". The jeopardy that we face in California applies to your state as well. I tried to accent that fact in this article. Californians were lucky enough to discover how the federal strategy was being set for future total and complete disarmament. The Small Arms Treaty now will put the *icing on the cake!*

It is important for gun owners to know what conditions to expect and what they will have to deal with. In other words, the stage has already been set by the anti-gunners to claim that the people of the nation have given their permission for total prohibition for all handguns, even though the federal government will not disclose the fact that it was an unlawful action. There was no permission from the people to disarm them, and to supersede the Second Amendment in the *Bill of Rights*. When the federal government issues an order to ban all handguns, they will rely upon this preliminary "permission" -- the ground work previously arranged by the L.E.A.A. to justify federal authority to ban all handguns. It is important that you have a pro-gun constitutional governor at the head of your state as well as an understanding of the situation in which the L.E.A.A. has placed you.

A VOTE FOR JERRY BROWN IS A VOTE TO SURRENDER YOUR HANDGUNS!

Jerry Brown is anti-gun. He is the sort of person that Barack Obama would like to have heading a major pilot state so that Obama may complete negotiations on the *Small Arms Treaty* when he is 'tasked' to order confiscation of all privately owned handguns. The *Small Arms Treaty* is inching ever closer for Obama's signature.

Years ago (in 1975) Jerry Brown had been governor of California. At that time Brown allowed this page (on the right) to remain on the records, even though it was sneaked into the Master Set of *California State Standards & Goals*, totally unauthorized or approved by the people. It was counterfeit, yet inclusion meant that the orders on its page represented "the will of the people," *their approval and consent!* This page *falsely claims* that the Commission answering to the federal government had acquired "permission" from California's population to prohibit their private possession of all handguns and they also approved a Surrender Agency" to collect their surrendered handguns!

Page 340 (which you see on the right) would have had to be sneaked into every other state's Master Set of "updated" *Standards & Goals*, just as it was found sneaked in the back of the Master Set in California. Your permission to disarm you has been unlawfully passed as law during Brown's first term as governor!

The manipulation of one state alone could not release the protection of the Second Amendment. Logic tells us that the federal and states' quest to comply to the appalling law already passed for General & Complete Disarmament of the United States (Public Law 87-297) would require cooperation from all of the states in the nation. Further, the Page 340 maneuver would have to be sneaked into all Master Sets of *State Standards and Goals* throughout the nation, (not just the State of California) in order to discontinue exercise of the Second Amendment of the Bill of Rights. Most likely this was accomplished. Without these tricky counterfeit manipulations, and the people's (so-called) "permission" to dismiss the Second Amendment, passage of the *Small Arms Treaty* would not be considered legitimate by other nations involved in the world-wide United Nations *Small Arms Treaty* ratifications.

Page 340 was first discovered in the final version of *California's Standards and Goals* at the end of 1974. Brown's administration as California's governor began in 1975, but he refused to discuss the unauthorized addition (of Page 340) to the *State Standards and Goals*. In spite of a citizen outcry against the entrapment by Page 340, Brown never denounced its presence, nor took action to have its presence condemned. He refused to meet with the opposition and ignored their pleas! Page 340's manipulative and dishonest maneuvering *set the stage* for fulfillment of Public Law 87-297. Because of the piece-meal operations in bringing about total and complete disarmament, the first deadline of 1983 did not work out. The federal government had to reset a new date. What the people need now is an honest pro-gun governor in every state, plus a National Investigation under trustworthy citizens in control of exposing the dishonest groups that have been setting these traps.

Meg Whitman is no better than Brown! They are two peas in the same pod. In a two-faced lie, Meg says she "supports the Second Amendment," but adds that an assault weapons ban and handgun restrictions are "probably the right thing in California." If she supports the Second Amendment, then why hasn't Whitman promoted protection and restoration of the militia (the whole people) as George Washington established it: to protect us from tyranny in government? Militia training was mandated practice for every man until the Civil War weakened it. Our best bet is to elect a Constitutional 3rd party this next election. Chelene Nightingale, a candidate for governor, is very pro-gun.

RECOMMENDATIONS

Enforcement of Current Laws

The Commission recommends that existing Federal, State, and local laws relating to handguns be strenuously enforced. It further recommends that states undertake publicity campaigns to educate the public fully about laws regulating the private possession of handguns.

Penalties for Crimes Committed With a Handgun

The Commission urges enactment of State legislation providing for an extended prison term with a maximum term of 25 years for committing a felony while in possession of a handgun.

Stop-and-Frisk Searches

The Commission urges the enactment of State legislation providing for police discretion in stop-and-frisk searches of persons and searches of automobiles for illegal handguns.

Prohibiting the Manufacture of Handguns

The Commission urges the enactment of State legislation prohibiting the manufacture of handguns, their parts, and ammunition within the State, except for sale to law enforcement agencies or for military use.

Prohibiting the Sale of Handguns

The Commission urges the enactment of State legislation prohibiting the sale of handguns, their parts, and ammunition to other than law enforcement agencies or Federal or State governments for military purposes.

Establishing a State Gun Control Agency

The commission urges the enactment of State legislation establishing and funding a State agency authorized to purchase all voluntarily surrendered handguns, and further authorized to register and modify handguns to be retained by private citizens as curios, museum pieces, or collector's items.

Prohibiting the Private Possession Of Handguns

The Commission further urges the enactment of State legislation not later than January 1, 1983, prohibiting the private possession of handguns after that date.

RECOMMENDATIONS

Enforcement of Current Laws

The Commission recommends that existing Federal, State, and local laws relating to handguns be immediately reinforced. It further recommends that most executive publicity campaigns to educate the public about laws regarding the private possession of handguns.

Penalties for Crimes Committed With a Handgun

The Commission urges enactment of State legislation providing for an extended prison term with a minimum term of 25 years for committing a felony while in possession of a handgun.

Stop-and-Frisk Searches

The Commission urges the enactment of State legislation providing for police discretion to stop and frisk, search for weapons and search for contraband for illegal handguns.

Prohibiting the Manufacture of Handguns

Establishing a State Gun Control Agency

The Commission urges the enactment of State legislation establishing and funding a State agency responsible to purchase all voluntarily surrendered handguns, and further authorized to register and classify handguns to be retained by private citizens in their homes, places, or vehicles.

Prohibiting the Private Possession of Handguns

The Commission further urges the enactment of State legislation not later than January 1, 1983, prohibiting the private possession of handguns after the date.

It contains your permission for all of your handguns to be confiscated!

Question: Who said I gave any permission for my handguns to be confiscated?

Answer: Most likely, you didn't, but your local citizen committees may have done so -- on your behalf. The attached article explains what has happened to gun owners.

Question: Why should I, as a gun owner, be concerned about Page 340, when it is dated January 1, 1983? That date has passed. Isn't Page 340 obsolete by now?

Answer: No, it is not obsolete. Even though the 1983 date has come and gone, Page 340 fulfilled several federal objectives. Page 340's main objective was to document the fact that the federal government had acquired the permission of the people (even though it was a fraud and a forgery) to allow for the prohibition of all handguns, the possession, use, manufacture, and/or sale in American society. The federal government has always had the option of changing the date they first set. Page 340 still retains its viability as the approval of the people: *their consent to disarm them*. Creation of Page 340 laid a foundation for the *Small Arms Treaty* to be effective when signed.

Question: Since the right to keep and bear arms is listed in the *Bill of Rights* and was ratified by the people, how can this right be subjected to repeal or denial?

Answer: If the government can show that the people "requested that they be denied the use of this right, or that they disapproved of their fellow citizens possessing handguns", global government advocates can more easily claim they are following 'the will of the people', and that they are authorized thereby. It is essential that the people are aware that Page 340 came about due to scandalous conduct by anti-gun government officials, and the danger it created still exists!

Question: Can we refuse to surrender the right to keep and bear arms, even under martial law?

Answer: The answer is "yes" and "no", depending upon whether you are "willing" or "not willing" to be swindled! Barack Obama hasn't given proof as yet of his authority to sign the Small Arms Treaty since the claim of his being "natural born" is still in question. Any treaty which is not "in pursuance thereof" (to the Constitution and the Bill of Rights) or not consistent with essential Constitutional principles and rights, cannot claim to be, nor be held to be, lawful. Any attempt to disarm the whole nation, by use of martial law or executive orders, can only be classed as intolerable subversive activity, and should confirm the existence of tyrannical and unfit rule.

Question: How do we get rid of Page 340?

Answer: Citizens Advisory Committees, which represented all of the people and approved of the changes being made to the Standards & Goals, never studied the gun issue! There is no statutory limit on fraud! Page 340 is a fraud, and while there is still time, should be exposed as a hidden federal swindle! An expose' must be demanded to restore the sanctity of the Second Amendment of the *Bill of Rights*. **Don't wait until it is too late to remedy this evil situation.**
