To the Supporters of the Second Amendment:

It appears timely and necessary for those of us who treasure the system of government our nation's founders established by instituting three essential documents to protect our rights, our liberty, freedom and justice, to come forward in defense of these documents, and to insure the continuance of the blessings they bring. As a California State representative for 18 years, I seriously took the oath to support and defend these three essential documents, and our system that holds limits on the power that government may exercise over the people. It is up to us, the living, to preserve what was so costly gained by the nation's founders, as they established our republic. This is a task that we can never achieve if we are to continue allowing some of our representatives to generally and completely disarm us, as a nation, and as individuals.

When the American government first began to function, it was unthinkable for public officials to consider disarming the people. It is still a commonly recognized fact that liberty and our three essential documents can endure only as long as the people of the nation remain armed citizens! George Washington said: "When firearms go, all goes! We need them every hour."

Please read carefully through the lengthy but important letter that follows, and realize that your right to arms is dependent upon changing the circumstances which exist. Only if you give your personal attention to these facts will we be able to avoid a series of tragic events: (1) the total banning of all privately-owned handguns under the Small Arms Treaty; (2) how you are controlled by the ground work which has been secretly laid (Page 340 and Page 341) which falsely claims the 'permission' of the people was given for total prohibition of all their handguns; and (3) the planned collapse of our economy and our 50 states for the benefit of installing a "new world order" – a deliberately engineered world government system takeover.

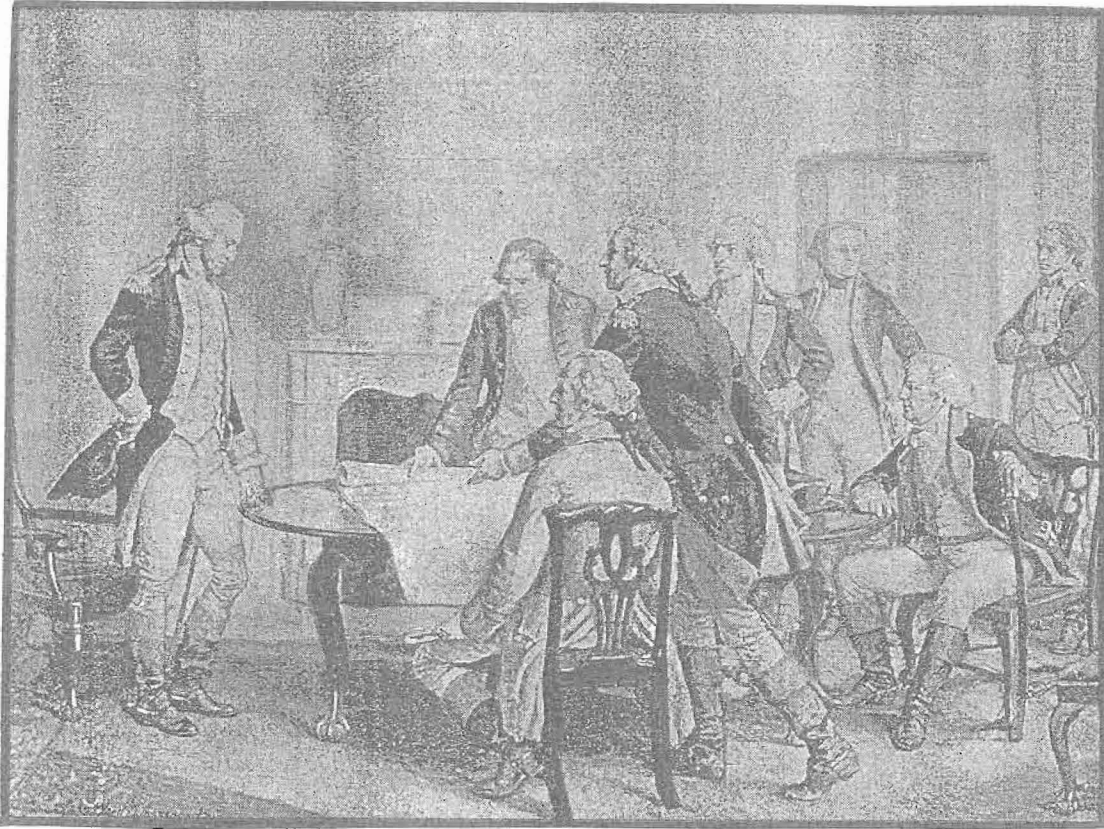

Don Rogers

They Provided Us With Three Essential Documents
and Gave Us the Means To Be Able To Hold On To Them.



(1) By July 4, 1776, the "Declaration of Independence" was drafted, the purpose of which was (a) to become free of England's rule and "the divine right of kings"; (b) to declare that all people are created equal; (c) to confirm that the people are endowed with certain unalienable rights, individually and collectively; and (d) to declare that government derives its *just* powers from the consent of the governed.

(2) By September 17, 1787, the "Constitution" had been laid before the Congress, the purpose of which was to distribute political authority so that limits could be kept on the power that man can exercise over his fellow man. It was meant to prevent tyranny in government.

(3) By December 15, 1791, the "Bill of Rights" having been declared necessary, added *ten amendments* to the *Constitution*, the purpose of which was to protect the most endangered rights of the people. The Second Amendment confirms that the natural right to keep and bear arms, individually and collectively, was endowed to the people by the Creator, and it is the keystone right! It was meant to be the perpetual and necessary force to preserve liberty, freedom and justice. The Second Amendment was commanded to be kept free from all infringements, because without arms, we shall lose all three essential documents!

However, by 1975 the federal government had caused an unlawful page to be *secretly* added to the State Standards and Goals so that the federal government could (falsely) claim it had a recommendation from the people to prohibit the people from exercising the *keystone* right in the "*Bill of Rights*". The purpose of this assembly of papers is to show that (a) there *never was any consent of the governed* nor any other basis to allow government to prohibit the people's use of firearms; (b) there *never was any consent of the governed* to approve general and complete disarmament treaties on the USA; and (c) the enforcement of the *Small Arms Treaty* is against the law in the USA. May God grant us the strength, courage, and wisdom of our forefathers to be able to preserve our arms, and all 3 of our nation's vital documents.
